Please be advised that the Board of Directors of Euro-Med Laboratories Phil., Inc., at its regular meeting held yesterday, 23 February 2016 at 5:00p.m. in which a quorum was present throughout, unanimously discussed and approved the acquisition from Antech Nutritional Technologies (hereinafter, "Antech") of the "Dr. Edwards" brand (hereinafter, the "Tradenname") and the entire inventory of products being manufactured, sold and distributed under the Tradenname, such as but not limited to, bottled water, purified water, fortified water and sterilized water (hereinafter, the "Products").
